Dear Resident,

This letter serves as a follow-up to the letter that was sent on June 5, 2015, informing you of the pending demolition of all the structures minus the warehouse, on the Former Consumer Product Safety Commission Site.

On October 7, 2015, the City of Gaithersburg issued Permit Number: Demo-9097-2015 to Demolition Services Inc. (DSI) out of Culpeper, Virginia. With the issuance of this permit, the City of Gaithersburg has notified DSI they may now proceed with their demolition work on the site. DSI intends to begin demolition work starting on October 12, 2015.

As previously provided, the majority of the work on site will be completed by December 2015. All work will take place between the hours of 7 a.m. and 7 p.m., Monday to Friday, in accordance with the City of Gaithersburg Noise Ordinance. If work is required outside of these normal working hours, this work will be coordinated with the City and a notice will be provided to the residents via flyer.
